

# HIGH OLEIC SOYBEAN OIL SWEEPSTAKES - OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. **PROMOTION DESCRIPTION:** The HIGH OLEIC OIL SWEEPSTAKES ("Sweepstakes") begins on AUGUST 14, 2019 AT 9:00 a.m. CDT and ends on AUGUST 14, 2019 at 12 p.m. CDT ("Promotion Period"). Entries that are submitted before or after the Promotion Period will be disqualified.

The sponsor of this Sweepstakes is AGRICULTURAL UTILIZATION RESEARCH INSTITUTE, INC. ("Sponsor"). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Sweepstakes. Only one (1) person or household working in a foodservice company or organization will be awarded the Prize. Prize cannot be transferred, redeemed for cash or substituted by winner. Sponsor reserves the right in its sole, exclusive, and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The Approximate Retail Value ("ARV") of the prize represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the Prize turns out to be less than the stated ARV, the difference will not be awarded in cash.
